Certified that, **JR International School, Chennai – Trichy National Highway, Avanampattu Village, Tindivanam Taluk – 604302 Murukeri Block, Villupuram District**, has been inspected on 16.06.2025 by the Block Health Supervisor, Murukeri Block and the building and premises are found satisfactory on the following aspects.

- The accommodation provided for each of the classrooms and halls is sufficient for the minimum number of Students.
- Ventilation, lighting that the building is maintained in substantial repair (with hot lime wash / color wash should be done once in a year) and sanitary arrangements provided are adequate and satisfactory.
- The supply of drinking water is wholesome and protected.
- The latrine arrangements are adequate and satisfactory.
- Premises and surrounding are maintained neat and clean.

THIS CERTIFICATE IS ISSUED SUBJECT TO THE FOLLOWING CONDITIONS.

- On any account, the Garbage kept more than 24 hours or shall not be burnt in the premises and should be collected and segregated then disposed by appointing required Sanitary Staff. Plastic wastes never burnt in the school premises.
- Usage of Plastics is prohibited & Display Plastic Free Zone sign board prominently.
- Fire NOC should be produced and First Aid Box should keep easily accessible with long expiry drugs and other essentials. Trained Persons name list to be produced of the fire fighting utilities and mock exercise should be carried out in valid time interval. Separate OHT provision should be erected for the centralized fire and smoke sensor implanted complex.
- Child Labor should not be engaged on any account. In hospital premises all wards, laboratories, operation theatre complex must have BMW disposal practices.

- Over head Tank and Water Sump shall be hermetically sealed and scientifically closed and shall maintain a register regarding periodic cleanliness.
- Drinking Water shall be chlorinated and shall have 0.5ppm of Residual Chlorine. Water samples from Source and the dispersing point should be investigated in designated Govt. water lab by complete analysis basis twice a year.
- Flies / Mosquitoes breeding shall not be permitted within the premises.
- Emergency fire exit plan should be affixed prominently in various and denoted places with medical and other essential help line numbers invariably.
- Rain water harvesting system should be maintained as per norms.
- Incinerator should be installed and maintained for Hazardous Waste disposal.
- Any out Break of Communicable Disease must be informed to The District Health Officer, Villupuram HUD / Block Health Supervisor, Murukeri - Immediately.
- Timely Vaccinations as prescribed by the Government of Tamilnadu should be administered in the appropriate age by the Health Care Providers or by Private Health care centers (Proof to be produced in the prescribed Format).
- Display and exhibition of Board: As per Rule 3 of the Tamilnadu Prohibition and Smoking and Spitting Rules 2003. "Anti Tobacco and Say no to Drug" regarding self declaration should be obtained by the management.

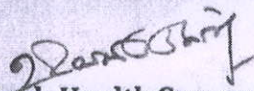
- ✓ Every person in charge of the place of public work or use shall display and exhibit a board at a conspicuous place in or outside the place prominently stating that the place is as "No Smoking and No Spitting Zone" and that "Smoking or Spitting here is an Offence" which shall be both in Tamil and English and the version in English in the second place below the Tamil. Tamil Version shall be written predominantly in the board by providing more space than English.

This certificate is *liable to be cancelled at any time on infringement* if any of the above said conditions and for improper maintenance of Sanitation and building and, if any, health nuisance if found as defined in Section 41 of the Tamilnadu Public Health Act, 1939.

This Certificate is Valid for the period of One Year from the Date of Issue.

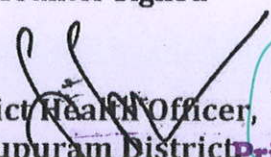

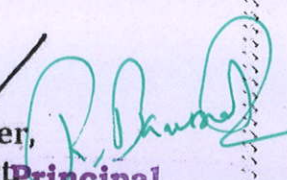
