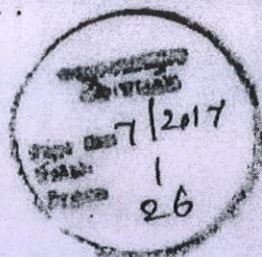
THIS DEED OF DECLARATION OF TRUST executed at Chennai on this 12th Day of January 2017

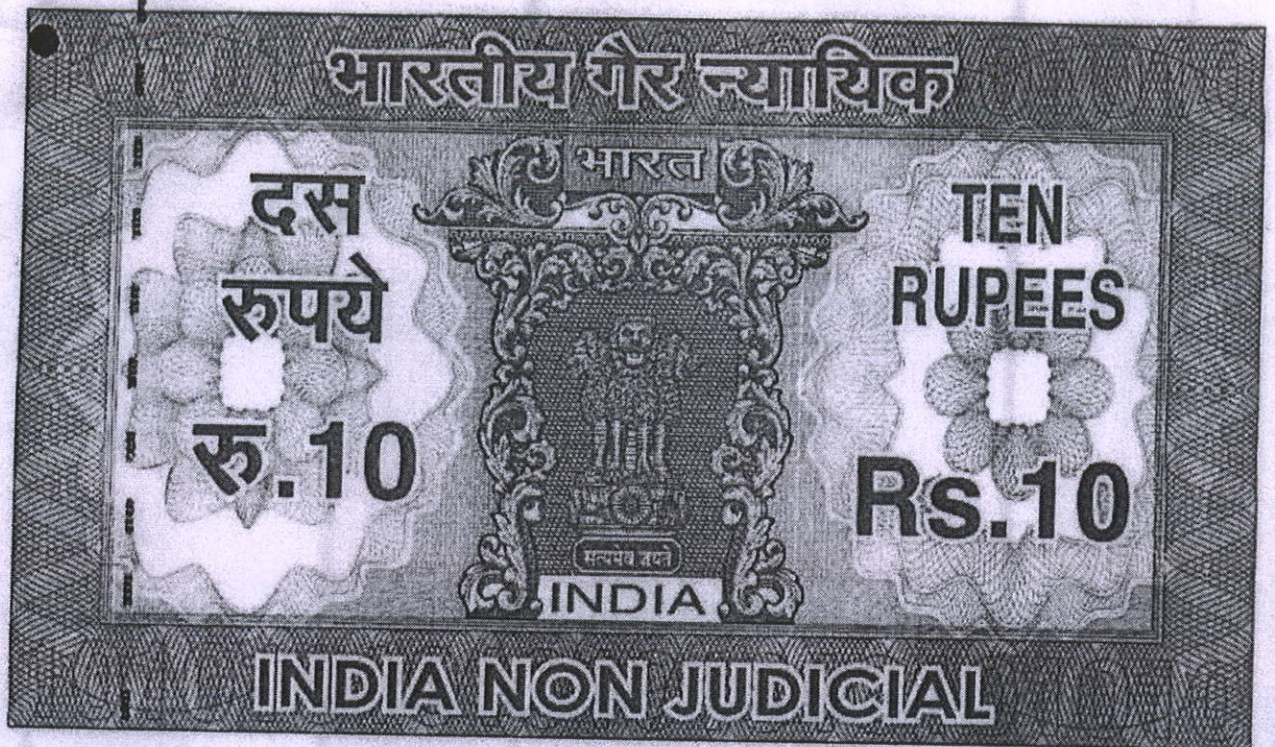

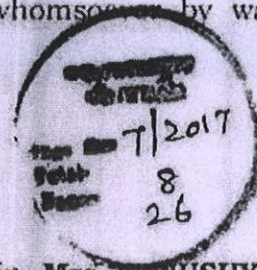
f. The Trust shall receive any voluntary contribution whether in cash or in kind from any person from any sources, whomsoever by way of donation, legacy from India or abroad.

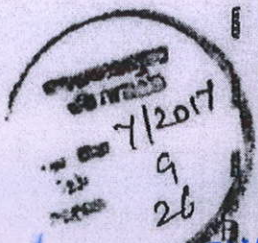

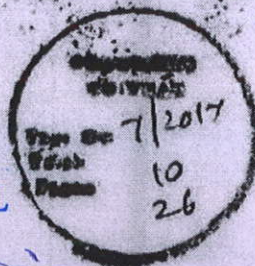

The TRUSTEES shall hold an Annual General Meeting, consider and approve the annual accounts, budget, proposal, Annual Report and matters brought before.

D. In addition to the annual general meeting, the TRUSTEES may meet from time to time as may be convened by the MANAGING TRUSTEE and shall transact any business that may be specified in the AGENDA or otherwise agreed by the TRUSTEES. 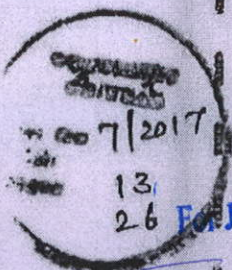

The MANAGING TRUSTEE shall have power of authority

or engage and at their discretion, remove, dismiss, or suspend any of the officials or employees or servants in permanent or temporary or special service in connection with the work of the Trust as they may from time to time think fit and to determine their powers and duties and fix their salaries, bonus, or emoluments and to require security in such instance and at such amount as the Managing Trustee may think fit.

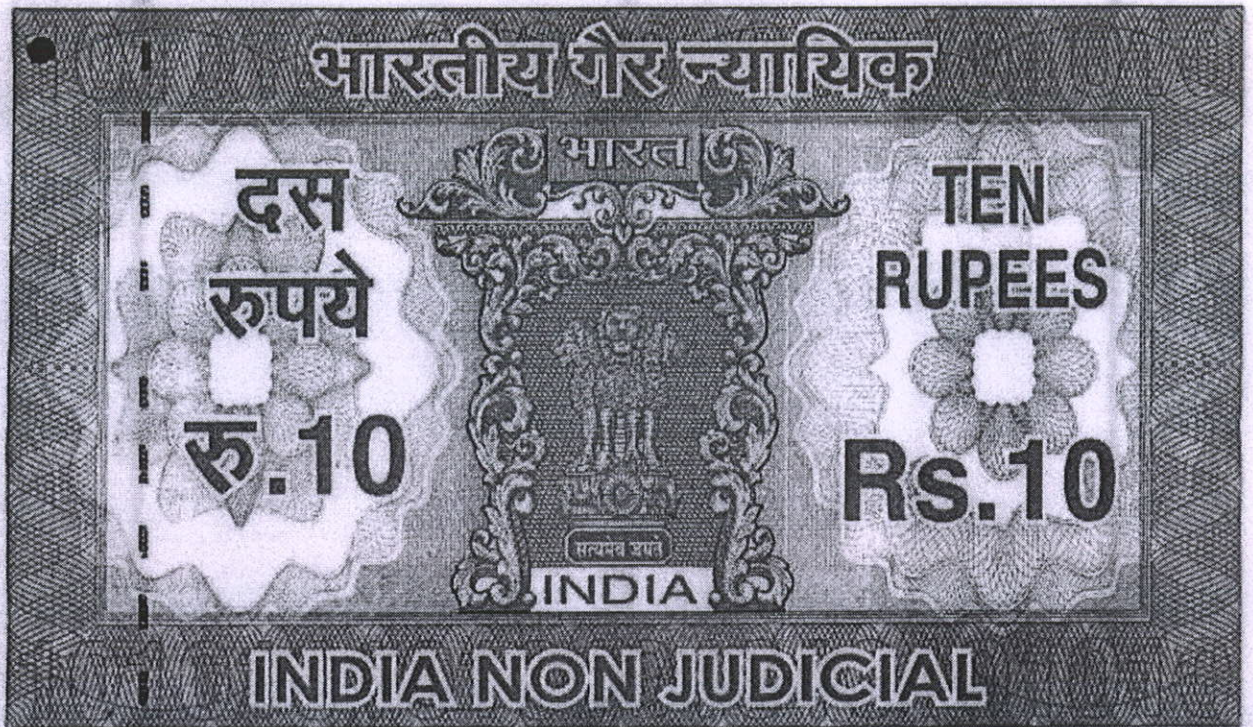

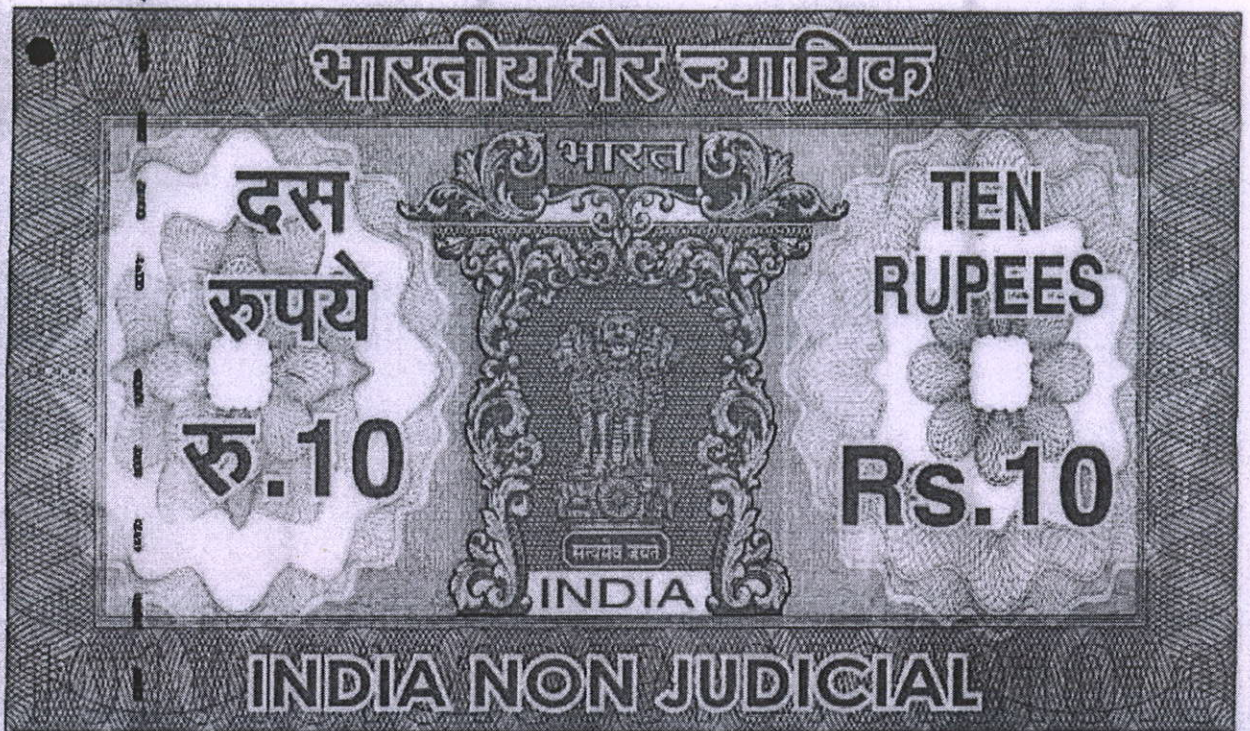

(xi) For the purpose of carrying out the object of the Trust, the TRUSTEES shall have power to acquire by purchase or on lease or otherwise any immovable property of any tenure and in case of vacant land, the Managing Trustee shall at liberty to erect buildings thereon and do all acts necessary and incidental thereto.

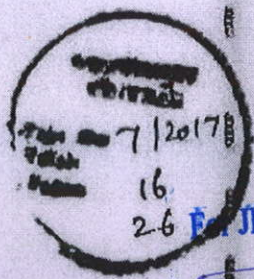

(xiv) The MANAGING TRUSTEE shall have powers to compromise, compound and refer to arbitration all actions, suits, proceedings and disputes touching and concerning the Trust properties or any other issue.

(xvi) Without prejudice to the above and in addition thereto, the TRUSTEES shall have all such powers as may be necessary for carrying out the objects of the Trust and for performing their duties and functions under the Trust including the power to amend any of the provisions of this trust by a resolution in a meeting of the trustees duly convened for that purpose, which shall be carried out

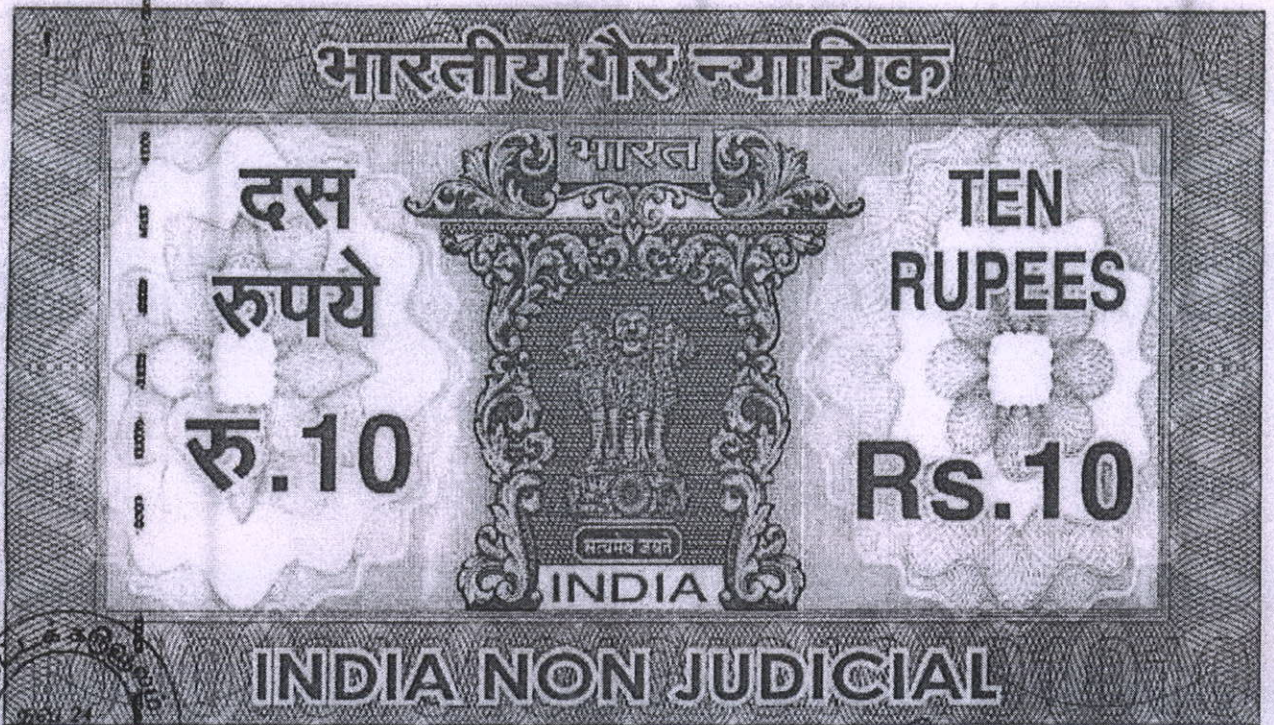

by the MANAGING TRUSTEE. However the TRUSTEES shall not have the power to amend, in any way, the main objects of the TRUST. There should not be any remuneration to the trustees out of trust fund and the trust activities should not be carried out of India. In case of winding up of the trust the any assets and liabilities of the trust should be transferred to any other trust having similar objectives and none should be distributes among the trustees.

8. DELEGATION OF POWERS

(i) The MANAGING TRUSTEE may delegate in writing all or any of his/her powers and authorities to his/her other CO-TRUSTEES who will be entitled to exercise such power or powers in the same manner as the MANAGING TRUSTEE himself or herself could have personally done.

(ii) The TRUSTEES may, by a resolution direct that any act, deed or thing required to be done or executed by them may be done or executed by any one or more of them and in such cases any act, deed or thing done or executed in pursuance of such resolution shall be valid and effectual as if it have been done or executed by all the TRUSTEES. Such delegation of authority may be general or special.
